**SURVEY ON HEALTH PROTECTION MEASURES ONBOARD SHIPS DURING THE
COVID-19 PANDEMIC**

Action required: Members are invited to note the ICS “Survey on health protection measures onboard ships during the COVID-19 pandemic” and to circulate the survey link to the survey to their member companies with encouragement to complete it by 19 June 2020.

Members will be aware that the COVID-19 pandemic has required companies to introduce various measures onboard their ships to protect the safety and health of seafarers, often building on existing plans and procedures in their SMS.

Recognizing the experience gained by companies during the COVID-19 pandemic to date, Members are advised that ICS is collecting information regarding these health protection measures, including procedures that they have introduced onboard their ships in response to the coronavirus (COVID-19) pandemic.

Such information will help ICS and Members gain a further understanding of the health protection measures introduced by companies onboard their ships, and will support efforts to address some the challenges being faced by companies.

Therefore, ICS has developed a **Survey on health protection measures onboard ships during the COVID-19 pandemic**, which can be accessed using this link:

Members are invited to circulate the survey link to their member companies with encouragement to complete it by 19 June 2020.

Companies should be advised that:

- Survey is estimated to only take about 10 minutes to complete, particularly as almost all the questions require only YES/No answers;#
- Participation in the survey is entirely anonymous (i.e. it contains no request for information about name of respondent, name of company or names of ships);
- Completing the survey will support efforts by ICS and its Members to address some the challenges facing companies during the pandemic related to protection of the health of seafarers.

Members are advised that a copy of the questions is provided at the **Annex**.

This is intended to provide Members with an overview of the questions to review and assess how to circulate in their member companies (likely QHSE department or similar). It should also be circulated to their member companies to ensure the survey is completed by a person with information available to respond to the survey.

Since the first question of the survey asks the respondent company to indicate their membership of a national shipowners' association from a list of ICS Members, the ICS Secretariat will, upon request, be able to provide Members with the responses data and results from their member companies at the end of the survey period.
